### Final Club Charity Registration Certificates

I wanted to inform you that our accountants have been working diligently with the AG office to file your club's registration. However, due to the high volume of applications, the AG office is currently experiencing a backlog of 8-12 weeks.


In the next few days, your club's designated contact person will receive an email from the Commonwealth of Massachusetts "public charities DO NO REPLY." Please remember to check your spam folders, just in case the email ends up there by mistake. Additionally, I wanted to remind you about the importance of the **Certificate of Solicitation**. Each club is required to have this certificate and renew it annually. If you have already received your certificate, **kindly send a copy to our headquarters:**
