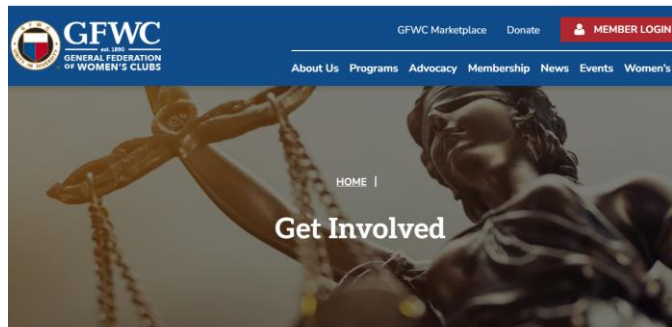


## HOW TO REGISTER FOR THE GFWC LEGISLATIVE ACTION CENTER (LAC)

Many members recently attended your GFWC Region's Annual Conference, during which Katie Robey presented a mini workshop suggesting how to implement the steps of the Legislative Ladder using a GFWC Resolution.
